**SCHEDULING NOTICE**


A telephonic case planning conference is scheduled in this matter for **Monday, September 8, 2008, at 2:00 p.m.** Alaska time. This conference will be combined with a case planning conference in *Matter of Diagnostic Health Anchorage*, OAH No. 08-0446-DHS. These matters are related to a prior consolidated case (OAH Nos. 06-0743-DHS & 06-0764-DHS).

The first order of business will be to discuss whether the two new matters are suitable for consolidation or should proceed as separate cases. The second will be to discuss whether and, if so, how best to structure the proceedings to bring forward and supplement, as necessary and appropriate, the existing record for the prior consolidated case. A related subject will be whether the issues raised should be bifurcated or sequenced to reach a commissioner-level resolution on some before expending resources to hear others.


Other subjects for discussion at the conference include whether this matter can be resolved without an evidentiary hearing; when and where the hearing will be held, if one is necessary; and what, if any, prehearing actions such as depositions, briefing, exchange of documents or pre-filing of exhibits should take place.
