Enclosed is a copy of a transcript of the Court's Findings of Fact and Conclusions of Law and the proposed Preliminary and Permanent Conditional Injunction and Declaratory Judgment in the matter of Banner Health d/b/a Fairbanks Memorial Hospital/Denali Center vs. Karleen Jackson, Commissioner of Health and Social Services and Alaska Open Imaging Center, LLC (Case No. 4FA-06-1377 Civ.). As discussed in my letter to you dated August 17, 2006 I believe the Court's finding in the Fairbanks case requires Imaging Associates of Providence, LLC to submit an application for a certificate of need for its imaging facility in the Matanuska-Susitna Valley.

After reviewing the Fairbanks decision in detail, I now feel obligated to provide you with a timeline for you to submit and the department to process a certificate of need application for your Mat-Su facility. In the absence of a lawful Certificate of Need granted by the department by Tuesday, February 13, 2007, I will request the Department of Law to seek a Court order enjoining Imaging Associates of Providence, LLC from operating its Mat-Su imaging facility as of that date. February 13, 2007 is 180 days from August 17, 2006, the date you were initially notified of your obligation to apply for a certificate of need for the Mat-Su facility.

In order to provide the department with sufficient time to process a certificate of need application, I must therefore insist that you submit an application to the department no later than close-of-business Monday, October 16, 2006. Should an application be received on that date, and barring any intervening events that would dictate otherwise, I would anticipate the process to unfold as follows:

The timeline above assumes that both Imaging Associates of Providence, LLC and the department complete their work as quickly as possible and that neither the applicant nor the department will seek any additional time extensions permissible under the certificate of need program statute and regulations.
