Thank you for your email dated October 4, 2007 requesting additional information regarding our application to build an 8 station dialysis clinic in Soldotna. For ease of reference, this letter follows the format of your email.

***Does Liberty Dialysis plan to buy or lease the proposed site?***

Liberty Dialysis intends to lease the proposed space.

***What is the proposed cost of the purchase or lease? Please support these amounts with documentation.***

Liberty Dialysis anticipates that the lease cost will be approximately \$7,500 per month for the 5,000 square foot facility (\$1.50 per square foot per month). Attached as Appendix A hereto is a description of the property. We are currently negotiating a letter of intent with the landlord.

***Will the facility be single or multiple floors?***

Liberty Dialysis anticipates that the facility will be on a single floor.

***What type of construction? (Example, wood or metal frame, masonry, etc.)***

Liberty Dialysis anticipates that the facility will be concrete.

***Please submit the floor plan of a similar Liberty Dialysis facility.***

Liberty Dialysis believes that the floor plan will be substantially similar to the floor plan at Nampa, Idaho. Attached as Appendix B is a copy of such floor plan.

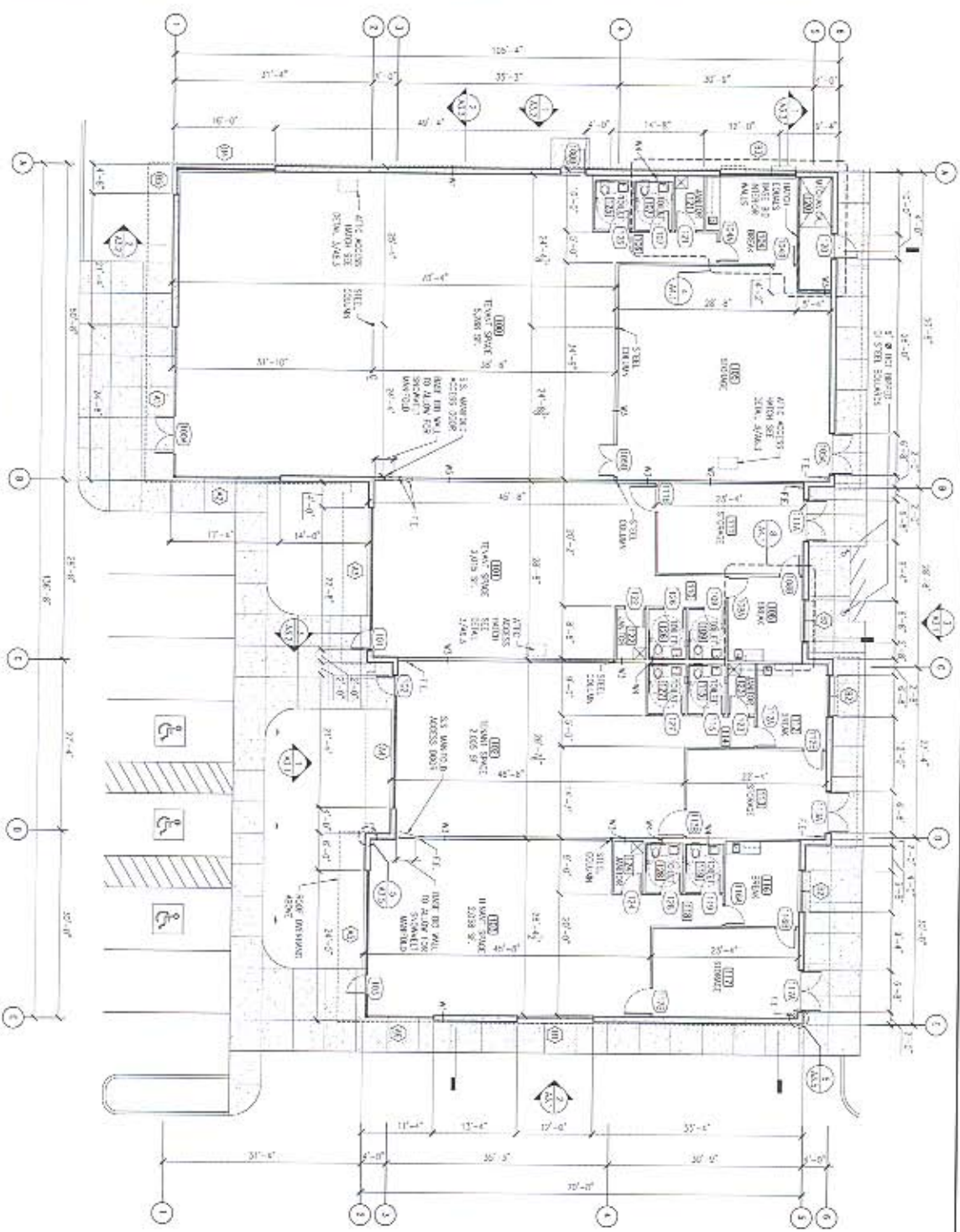
**1 FLOOR PLAN**

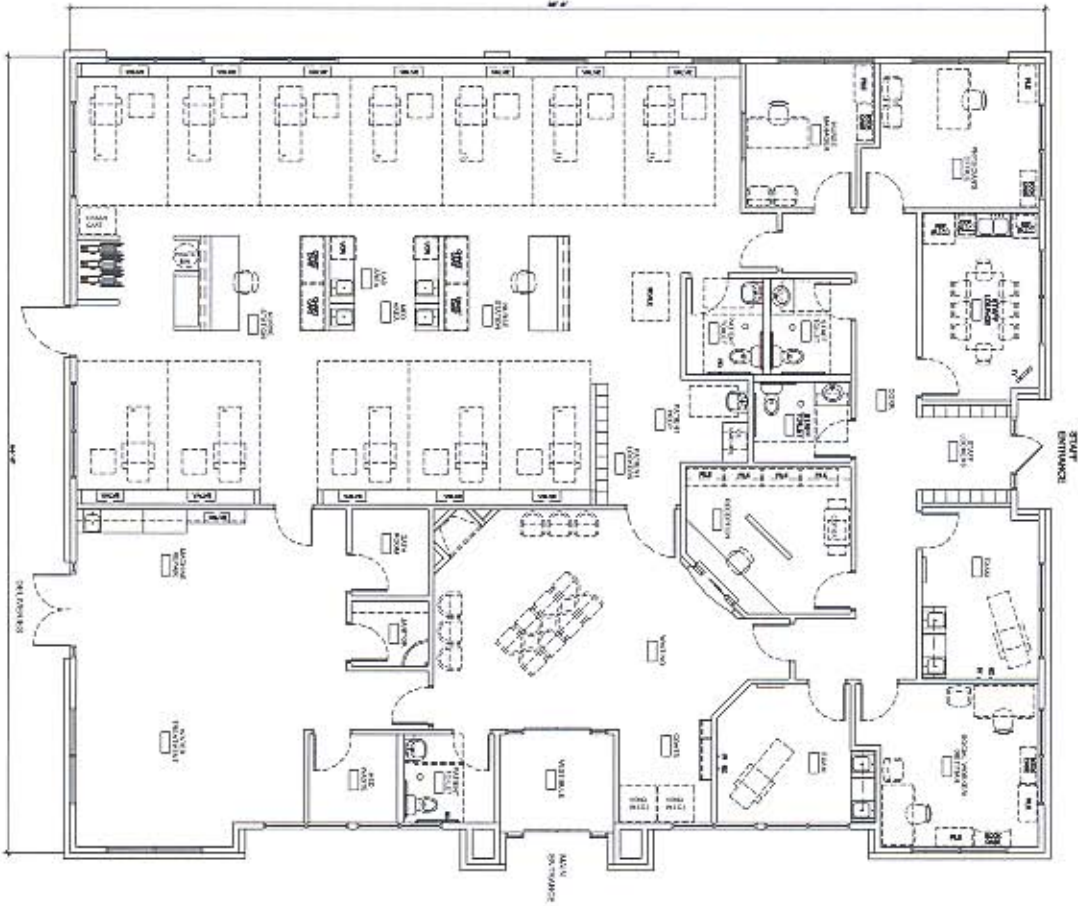

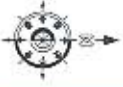
