

NOTICE OF COMPLETED APPLICATION FOR A CERTIFICATE OF NEED  
THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES

The Department of Health and Social Services (DHSS) has accepted a completed certificate of need application for the health care facility construction project described below and in accordance with 7 AAC 07.060 will conduct a review of the application received.

**Project/Activity:** Central Peninsula General Hospital, Inc. proposes to build a 5,227 square foot (SF) build-out addition. The project will add 1710 SF for a replacement Computed Tomography scanner, control room, equipment room and vestibule. The 3,210 SF will be shelled-in space for future replacements of the Magnetic Resonance Imaging and Nuclear Medicine modalities and reconfiguration of the imaging department to address code deficiencies and growth. The estimated project cost is \$3,843,796. The estimated completion date is November 2014.

**Applicant's Name:** Central Peninsula General Hospital, Inc

**Project/Activity Service Area:** Kenai Peninsula Borough

The application is declared complete and in accordance with AS 18.07 a staff analysis of the application and recommendation must be submitted to the Commissioner by October 18, 2013, unless additional time, not to exceed 30 days, is granted by the Commissioner. A decision by the Commissioner must be made within 45 days of receipt of the staff recommendation unless additional public notice is given that more time is required for the Commissioner to make a decision.
